General MacHrthur was an Engineer

In 1944, in the midst of his campaigns against the forces of Japan, Douglas MacArthur characterized the conflict in the Southwest Pacific as "distinctly an Engineer's war." The general knew more than a little about military engineering—he began his Army career as an engineer.

Graduating at the top of his class at West Point in 1903 entitled MacArthur to a commission in the Army's elite Corps of Engineers. The lieutenant's first assignment was with the 3d Battalion of Engineers in the Philippines. Other duties in the land for which he developed a lifelong attachment included surveying various camps and over-seeing the construction of wharves, sea walls, and roads.

Returning stateside in 1904, MacArthur was sent to San Francisco. Among his responsibilities there was service on the Corps' California Debris Commission. In 1905 he became acting chief engineer of the Pacific Division. The commander of the division was his distinguished father, General Arthur MacArthur, who secured for his son an appointment as his aide-de-camp. The pair embarked on an extended tour of the Far East.

In 1906 MacArthur graduated from the Engineer School of Application at Washington Barracks and briefly served as aide-de-camp to President Theodore Roosevelt. Next he had charge of river and harbor improvements along Lake Michigan. From 1908 to 1912 the young officer (promoted to captain in 1911) was stationed at Fort Leavenworth, Kansas, where he again served with the 3d Battalion of Engineers, taught in the Army Service Schools, and published a manual entitled Military Demolitions. During this period he also instructed troops at the Mounted Service School at Fort Riley, Kansas, and participated in exercises with the Maneuver Division at San Antonio, Texas.

MacArthur's intellect and ability drew praise from his superiors. Some, however, noted disturbing tendencies—verging on insubordination—to balk at unwelcome duties and to seek special privileges.

Participation in real hostilities came with America's entry into World War I. In peacetime, service in the Corps of Engineers offered a desirable career path, but the ambitious Major MacArthur knew that in wartime command of troops offered the best road to rapid promotion and honors. Accordingly, he secured a commission as a colonel of infantry in 1917.

There followed a spectacular and often controversial rise to prominence in three wars that made General of the Armies MacArthur the most visible and decorated soldier in America. Congress added to his laurels when, in an act of 1943, it designated a lock being built on the Saint Mary's River in Michigan as "MacArthur Lock." His retirement in 1951 closed out a career that began almost fifty years earlier when MacArthur was a promising officer of the U.S. Army Corps of Engineers.

Recipes...

Giant Ginger Cookies

4 ½ cups all purpose flour
4 teaspoons ground ginger
2 teaspoons baking soda
1 ½ teaspoons ground cinnamon
1 teaspoon ground cloves
¼ teaspoon salt
1 ½ cups shortening
2 cups granulated sugar
2 eggs
½ cup molasses
½ cup diced candied ginger pieces (optional)
¾ cup coarse Demerara, turbinado or granulated sugar

Preheat oven to 350 degrees Fahrenheit. In a medium bowl stir together flour, ginger, baking soda, cinnamon, cloves, and salt: set aside.

In a large bowl beat shortening with an electric mixer on medium or highspeed for 30 seconds. Add the 2 cups granulated sugar. Beat until combined, scraping side of bowl occasionally. Beat in eggs and molasses until combined. Beat in as much of the flour mixture as you can with the mixer. Using a wooden spoon, stir in remaining flour mixture.


Place the $\frac{3}{4}$ cup Demerara sugar in a small bowl. Using a #20 ice cream scoop or a $\frac{1}{4}$ cup measure, shape dough into 2 inch balls.

Roll balls in coarse sugar to coat. Place 2 ¹/₂ inches apart on an ungreased cookie sheet. (I chose to create 1 inch balls spaced about 2 inches apart on the cookie sheet. These are a good serving size for most uses and it makes about 6 dozen.)

Bake in a preheated oven for 11 minutes or until bottoms are lightly browned and tops are puffed (do not over bake). Cool on cookie sheet for 2 minutes. Transfer cookies to a wire rack to cool. Makes 24 cookies.

To store: Place cookies in layers separated by waxed paper in an airtight container; cover. Store at room temperature for up to three days or freezer for up to 3 months.

In Memory of Virginia Morsey Wheeler Talley February 18, 1919 - February 18, 2011



Virginia Morsey Wheeler Talley died after a very brief illness on February 18, 2011, exactly 92 years to the day after she was born. She had been a remarkable human being, a true emissary of Light, who graced the world with her calm and fearless presence. Her academic and professional accomplishments were extraordinary, but her fondest memories were of her two wonderful marriages and families. Virginia had the distinction of being the only woman in her law class of 1942 at Washington University in St. Louis, graduating Valedictorian, Phi Beta Kappa, and Order of the Coif. She was also voted the Editor in Chief of the Law Review Quarterly, the first woman to hold that position. Her professional career included 5 years with the Rural Electrification Administration, 12 years with the World Bank, and 15 years as a consultant to the United Nations and World Bank on matters usually concerning water resources development. Her contributions to her local communities were plentiful. Virginia inherited children and grandchildren through both her marriages and was genuinely loved by all. Her greatest gifts were her deep sense of peace within herself, the equanimity with which she viewed all peoples, her fearlessness and her compassion. Virginia's was truly a life well lived. A memorial service was held at Knollwood on February 26th to honor Virginia's memory. Her cremated remains will be interred at Arlington Cemetery in the spring. In lieu of flowers, memorial contributions can be made to the Virginia M. Talley Endowed Scholarship Fund in the School of Law. On February 12th AESC members & their spouses met at the Total Wine & More store in Chantilly for a private wine tasting. We arrived around 7 pm with appetizers in hand and were greeted by our wine instructor Trey and a table filled with bottles of 8 different wines from Australia and New Zealand. The theme for evening was a "Tour Down Under" featuring red and white wines from famous growing regions in those countries ranging in price from \$9.99 up to \$49.99.

For 2 hours we were guided through our tasting. Just imagine, we had glasses of a sparkling white (Brut), Savignon Blanc, Chardonnay, Pinot Noir, 2 different Shiraz, Cuvee and Cabernet Sauvignon. If you're wondering which specific wines, the Cuvee for example was a Shotfire Ridge Barossa Cuvee from the Barossa Valley in Australia. This wine has been featured as one of the 500 values for \$20 or less.

Trey provided us with lots of information on the wines that we tasted and on wine in general. Did you know that some of the oldest grape vines are in Australia? Or what the value is in decanting wines? Also many, many questions were asked by those of us attending and every one was answered. It was a fun informative evening where we enjoyed good food, good wines and of course, good company!



Voting Ballot for Proposed Changes to AESC Constitution and Bylaws

Approved by the Board on February 2, 2011

All dues-paying members of AESC may vote on the following proposed changes. Please enclose the ballot in an envelope with your name on the envelope but not the ballot and return it to AESC Ballot, P.O Box 6332, Alexandria, VA 22306-6332. The envelope must be post-marked by March 22, 2011.

Constitution:

Section II (page 36): Change to remove the words "military-connected" to define our service and welfare projects. (Yes_)(No_)

Section IV(2) (page 36): Change to read: The spouses of the following shall be honorary advisors to the Club: the Chief of Engineers, the Command Sergeant Major, the Director of Civil Works, and the Director of Military Programs.

(Yes) (No)

Bylaws:

Section I.A(2) (pp.37-8): Change to open Club membership to the spouses of all U.S. Army Engineers and to the spouses of all civilian employees of USACE.

(Yes___) (No___)

Sections VI.A and VI.B (pp.41-2): Change to separate the current "Service/Welfare" committee into "Ways and Means" and "Service/Welfare". (Yes_) (No_)

Section X (p. 44): Change to open the eligibility for candidates for both the AEMA awards and the Geraldine K. Morris Award to include any high school senior who is a U.S. citizen and whose sponsor is a U.S. Army Engineer or Department of the Army employee of USACE. The sponsor may be on active duty or currently employed by USACE, retired, or deceased. (Yes_) (No_)

Section X (p.44): Remove the following two sentences from the bylaws: Selection shall be made by evaluators appointed by the AEMA Chairman, with the consent of the Executive Board. This panel shall be made up of persons from outside AESC.
